Website Governance Committee Presentation

Ed Hineline – Director Information & Technology Charlene Collins – Coordinator IS

The website overhaul originated with the DAC concern in 2018. A committee was formed to review school website shortcomings and recommendations for improvement to make the websites viable, equitable, and accurate sources for parents and stakeholders to receive information as related to the District and schools.

Based on feedback and recommendations from the original subcommittee, a website checklist was formed. Training for content managers at school locations also emerged. Major areas of focus included location of content on the website, the accuracy of content, and up to date information. The committee also identified categories and content that should be maintained and pushed out from the District uniformly as opposed to components that should be school managed.

Key Adjustments include:

- Website consistency
- Training of all web content managers
- Timers and expiration of rotating banners (removes outdated banners/events)
- District pushed announcement and information
- Information provided in multiple languages
- Shared Apps (such and cafeteria and record an absence)
- Projected completion August 2021

Student Proposed Motions

The below motions were proposed by Rocco Diaz and will be revisited at the June face to face meeting.

Proposal 1: Minimum Age of Arrest

Implement into the rules and procedures of law enforcement in schools a provision that prevents law enforcement officers from arresting children under the age of 14 in schools.

I would have wanted this minimum age of arrest to be 18; however, I believe the age of 14 is something people can agree on. If there is a general consensus on a higher minimum age of arrest, such as 15, 16, 17, or 18, I would want such age to be the age in the provision.

Proposal 2: Climate Literacy Program

A group of stakeholders, including teachers specializing in the area of life science, shall prepare a series of at least two 45-minute-long lessons regarding climate change and other environmental issues. Variations of these lessons should be made for the elementary, middle, and high school level. Examples of lesson plans shall include, but not be limited to, the watching of a documentary and the answering of discussion questions, or the presentation of a powerpoint presentation prepared by the stakeholders and subsequent answering of discussion questions. The curriculum included in these lessons may include, but not be limited to:

The effect of greenhouse gases on global atmospheric temperatures

The effect of offshore drilling and pollution on ocean ecosystems

Sea level rise, its effect on ocean currents, and the resulting disruption of global weather patterns

The comparative effects of car use and public transportation on air quality

The effect of climate change on global migration patterns

Successful sustainability initiatives implemented at the local level

Intersectionality in climate change and environmental issues (ex: why climate change is more likely to affect poorer demographics, minority groups, and third world countries than any other groups of people

Climate gentrification

Plastic pollution

Methods and policies to curtail the adverse impacts of climate change (ex: carbon sequestration, carbon tax, cap and trade, training fossil fuel workers to transition into renewable energy fields)

The district shall implement a quarterly climate literacy day. On this day, at least 45 minutes of each student's science class shall be dedicated to the teaching of at least one of the lessons prepared. If a school has a block schedule, teachers of science classes will teach these lessons the next day. In order to account for differences in the political opinions of teachers, teachers shall be able to choose which lessons they teach as long as they teach all four lessons at least once throughout the year.

Proposal 3: De-euro centralization of History curriculums

The district shall form a commission of all stakeholders in this issue, including but not limited to anti-racist activists native to Broward, minority students recruited by the office of the Student Advisor to the School Board, and teachers who have taught African American History courses.

The district shall recommend that the committee read self-selected books about minority history as well as recommend youth-friendly books they have read in the past for students to read and discuss in their classes. One example of a possible book A Young People's History of the United States by Howard Zinn and Rebecca Stefoff, and another example is Ghost Boys by Jewell Parker Rhodes.

This commission shall form recommendations of additions to the regular curriculum that can be taught in elementary school, middle school, and high school in history classes–and make recommendations to teachers.

This commission shall work with BECON to make several videos that can be shown to students at multiple levels, including the elementary level, middle school level, and high school level, and prompt discussions that diverge from the normal curriculum. For example, the commission can encourage discussion about Christopher Columbus's harmful actions toward indigenous populations. These videos can be required to be shown either once a week, once per month, or once per quarter.

African American History courses currently offered to middle schools and high schools shall be expanded to schools that do not currently offer them

Elementary school "specials" shall be utilized. In elementary school, a different elective is taught each day of the week. For example, in elementary school, a single elective, such as physical education or art, is taught once per week or once every other week. Therefore, elementary schools shall charge one teacher, or hire a new teacher, to teach a class about minority studies prepared by the commission at the elementary school level either once per week or once every other week.

These classes shall serve two purposes. The first shall be to teach age-appropriate lessons about minority history without the misconceptions given by elementary, middle, and high school educational resources and textbooks. The second is to

prompt elementary-level discussion about implicit biases, their causes, and methods by which they can eliminate these biases

Book Exploration

There is currently a concern brought forth to the school board by the Fraternal Order of Police, District 5 regarding a book being read in some Broward schools 5th grade classrooms. The proposed motion reads:

"I move that the DAC form a committee to consider the book "Ghost Boys" by Jewell Parker Rhodes as a text permissible to be utilized by Broward Schools teachers. This group will consider the relevancy of current events, the text itself and objections presented by the Fraternal Order of Police, District 5 and create a recommendation to be presented to the school board."
